# 85th Annual Exhibition 2009 CALL FOR ENTRIES

**Dates** July 13 -September 6, 2009

**Location** Indiana State Museum — South Gallery  
White River State Park

**Eligibility** 2009 member of the Hoosier Salon. A one-year residency in Indiana at anytime in the life of the artist is required.

**Fees** *Nonrefundable* entry fee per artist is: \$40 for 1 entry or \$50 for 2 entries. Check or money order made payable to the Hoosier Salon, 714 E. 65th Street, Indianapolis, IN 46220

**Mediums**

2-D: All mediums including original prints & drawings

3-D: Any durable material

No photographs, reproductions, “scanners”, or porcelain

Entries must be original work of the artist. For example, 100% of a painting must be created by hand. No images produced by placing paint over a digital reproduction is allowed. The Hoosier Salon retains the right to disqualify a piece of work and to revoke awards and purchases if work is determined by the Hoosier Salon to be something other than originally presented.

**Rules for Entries**

Work executed in class or under the supervision of an instructor, copies of paintings and published photographs are prohibited.

Entry must have been completed in 2008-2009 and not previously exhibited in any juried show.

Any subject matter judged improper by the Hoosier Salon Board of Directors is prohibited. An entry in violation of the above rules will be removed from the exhibition and all prizes revoked.

## Please Note

- Hoosier Salon retains 33.3% commission on all sales.
- All entries MUST be for sale and reasonably priced.
- An entry may measure no more than 65” x 65” with frame, or 130” (width + length).
- Use plexiglass only on works 30” or 30” or larger.
- Sculpture: Please use discretion in size and weight.
- All 2-D artwork must be suitably framed and ready for hanging. Use flat strap wires only. (No screw eyes except on the inside of the stretcher frame to hold the wire.)
- All 2-D entries may tour throughout Indiana following the exhibit. The Hoosier Salon reserve(s) the right to determine whether works will travel.
- In 2009, actual works of art will be judged.
- No Digital or slide entries are necessary. (See drop-off location below)

## To Enter Your Work

1. Fill out the call-for-entry forms(s).
